




# Stitches of Love women take a summer break

Women and their children can wrap themselves in new one-of-a-kind hand-tied quilts at the Shelter for Abused Women, and grieving and hurting can find warmth and comfort in the softness of a beautiful prayer shawl.

Below is a summary financial statement of the Church's operations for the first quarter of 2014 compared to the budget for 2015. The financial success of 2015 is due to two principal

factors: the continued generosity of our parishioners and management control over expenses.

The combination of these two factors enabled St. John's to post a positive operating result of \$129,424 for the quarter. This will support our operations as we head into the summer months when expenses run normally, but revenues decrease sharply with the departure of our northern-based parishioners.



## Southwest Florida's Dabney Smith nominated for Presiding Bishop

**PARRISH** – The Rt. Rev. Dabney T. Smith, Bishop of the Diocese of Southwest Florida, is one of four candidates to lead The Episcopal Church as its



Presiding Bishop. The election will be held this summer at the church's 78<sup>th</sup> General Convention, which will be held in Salt Lake City.

In a letter to the Diocese, Bishop Smith said he was "deeply honored to be on this list of candidates."

"We are a healthy diocese with great claims upon us for the bold, compelling witness of the Gospel. If I am elected Presiding Bishop, the exciting work here will continue," said Smith. "If I remain the fifth bishop of this fine diocese, the exciting work here will continue."

Bishop Smith is one of four nominees put forward by the Joint Nominating Committee for the Election of the Presiding Bishop. The list also includes The Rt. Rev. Michael Curry of the Diocese of North Carolina, The Rt. Rev. Ian Douglas of the Diocese of Connecticut, and The Rt. Rev. Tom Breidenthal of the Diocese of Southern Ohio. To compile the initial slate, the committee culled through a list of 165 nominations representing over 60 dioceses. Video conferencing and face-to-face interviews afforded the opportunity for commission to get to know the candidates.

The nominating committee is composed of a lay member, a priest or deacon, and a bishop elected from each of the nine provinces of the Episcopal Church, plus two youth representatives who were appointed by the President of the House of Deputies.

The 78<sup>th</sup> General Convention of The Episcopal Church is June 25 – July 3 in Salt Lake City. The Episcopal Church's General Convention is held every three years, and is the bicameral governing body of the Church. It comprises the House of Bishops, with upwards of 200 active and retired bishops, and the House of Deputies, with more than 800 clergy and lay deputies elected from the 108 dioceses and three regional areas of the Church.

The Rt. Rev. Dabney Tyler Smith was elected bishop coadjutor of the Diocese of Southwest Florida in 2006. He was rector of Trinity Church, New Orleans and has served at Holy Trinity in Melbourne, Fla; St. Michael and All Angels in South Bend, Ind.; and Grace Church in Port Orange, Fla.

The Diocese of Southwest Florida represents 77 Episcopal congregations and 14 parochial schools from Marco Island north to Brooksville. Part of The Episcopal Church and the worldwide Anglican Communion, the Diocese includes some of the earliest churches in Southwest Florida.

If elected, the Rt. Rev. Smith would be the 27<sup>th</sup> Presiding Bishop of The Episcopal Church, which was founded in 1789. □

[Paul] found some disciples and asked them, "Did you receive the Holy Spirit when you believed?" They answered, "No, we have not even heard that there is a Holy Spirit." So Paul asked, "Then what baptism did you receive?" "John's baptism," they replied. Paul said, "John's baptism was a baptism of repentance. He told the people to believe in the one coming after him, that is, in Jesus." On hearing this, they were baptized in the name of the Lord Jesus. When Paul placed his hands on them, the Holy Spirit came on them, and they spoke in tongues and prophesied." (Acts 19: 1b -6)

This month the church remembers and celebrates a powerful and life-altering gift from God — the Holy Spirit coming at Pentecost. The giving of the Spirit at Pentecost is monumental because, as fellow Episcopal Priest Philip Brookes said in his sermon one Whitsunday (Pentecost), that the work of the Holy Spirit makes belief profound and duty delightful as it is "... a restoral of communication, that is a re-enthronement of God where He belongs..." And as author Charles Stanley states, "Each believer decides who rules his life, by either actively surrendering to Christ or deliberately going his own way. Even those who try to avoid the issue by making no choice at all, unknowingly opt for self-rule. The fullness of the Spirit and godly character await those who choose God over self."

The Holy Spirit does in and through us what we cannot do for ourselves. Just as we have been saved by Grace — which is not from ourselves but is a gift from God — so, brothers and sisters, we have been given the Holy Spirit: He lives in us, leads us, guides us,

speaks through us and uses us to bring the love of God and the blessings of His Kingdom to the hurting and broken world which exists all around us.
